Dividing the property into two SF-1 lots and replatting the property legally described as W.S. NEALE ADDITION LOTS 1 & 2 BLOCK 6 TO THE CITY OF LEONARD, TEXAS—Commonly known as Lots 1 and 2 S. Oak Street, Leonard, Texas, to run East and West for the purposes of building a structure.
