#### MINUTES OF THE SPECIAL SESSION

#### Calling Meeting to Order / Presentations / Proclamation / Citizen Comments:

- 1. Invocation The invocation was led by Councilman Bob Pannkuk
- 2. Pledges of Allegiance to the United State and Texas Flags Mayor Bolin led in the Pledge of Allegiance to the United States and Texas Flags.
- **3.** Call to Order Mayor Bolin called the meeting to order at 6:00
- **4. Proof of posting of Notice of Meeting** Mayor Bolin noted the proof of posting of meeting by City Secretary Leath Robinson.
- 5. Verification of Quorum Mayor Bolin noted the quorum of five councilmembers.
- 6. Adjourn into Executive Session under:
  - "Texas Government Code Section 551.071 regarding Consultation with Attorney: Receive advice 1) regarding pending or contemplated litigation; and 2) on a matter in which the duty of the attorney to the governmental body under the Texas Disciplinary Rules of Professional Conduct of the State Bar of Texas clearly conflicts with this chapter."

• "Texas Government Code Section 551.074 regarding Personnel Matters: Deliberate the employment, evaluation, reassignment of duties, discipline or dismissal of a public officer or employee and to hear a complaint or a charge against an officer or employee.

#### a) City Administrator position"

Councilman Pannkuk motioned to adjourn into Executive Session at 6:01 P.M. Second by Councilman Grintz. Mayor Bolin called for a vote--all were in favor and the motion carried.
