Government Code, Chapter 551, that the City Council of the City of Leonard, Texas, will meet to conduct a Public Hearing and a Regular Meeting of the City Council with the Public Hearing beginning at 5:30 p.m., Tuesday the 12th day of February 2019 and the Regular Meeting following immediately thereafter at the City Council Chambers at 111 W. Collin Street, the following subjects to be considered:

Public Hearing Application of a \$275,000 Community Development Block Grant

The City Council for the City of Leonard, Texas will hold one public hearing regarding the issue of: applying to receive a \$275,000 Community Development Block Grant for the purpose of street repair and incidental infrastructure repairs to portions of N. Park, W. Short, N. Main, and N. Parmele Streets located around the Suddereth Addition 2, North end Addition 2, and Watson Addition located adjacent to and due south of HWY 69.

Council to hear concerns regarding the application to receive a \$275,000 Community Development Block Grant to be utilized in offsetting the expenses to be incurred during the street repairs and incidential infrastructure repairs rezoning to portions of N. Park, W. Short, N. Main, and N. Parmele Streets located around the Suddereth Addition 2, North end Addition 2, and Watson Addition located adjacent to and due south of HWY 69.
