Call to Order, Proof of Posting of Notice of Meeting and Verification of Quorum Mayor Pye called the meeting to order at 7:00 pm with a quorum of five councilmembers. Mayor Pye noted the proof of posting of meeting by City Secretary Leath Robinson and noted the quorum of five.
