- 1. Invocation The invocation was led by Councilman Nixon. Pledges of Allegiance to the United States and Texas Flags. Mayor Pro-Tem Webster led in the Pledge of Allegiance to the United States and Texas Flags. Call to Order, Proof of Posting of Notice of Meeting and Verification of Quorum Mayo-Pro Tem Webster called the meeting to order at 6:37 pm with a quorum of four councilmembers. Mayor Pro Tem Webster noted the proof of posting of meeting by City Secretary Leath Robinson and noted the quorum of four.
