#### 2. Public Comment

Discuss, consider, and take any necessary action regarding approval of a Zoning amendment to allow the designation of the Historic Overlay District for the (C1) Commercial District, commonly referred to as the "Downtown Area" (application #PZ2025-014), the general location is the lots, tracts, and parcels of land that are located adjacent to and within one hundred (100) feet of the following street Rights-of-Way: (1) Collin Street from Connett Street to Main Street, (2) Connett Street from Collin Street to Fannin Street, (3) Fannin Street from Connett Street to Main Street, (4) Main Street from Collin Street to Fannin Street, if any portion of a lot, tract, or parcel is located within one hundred (100) feet from one of the above-referenced street Rights-of-Way, the entire limits of the property shall be considered to be located within the Historic Overlay District.
