Second by Councilmember Martin. Mayor Pye called for a vote – all were in favor and the motion carried.

Councilmember Martin motioned to approve Utility Billing Surety Bond. Second by Councilmember Stephens. Mayor Pye called for a vote – all were in favor and the motion carried.

City Administrator George Evanko stated that the approved TMRS change has gone into effect, the results of the Fannin Central Appraisal District Board of Directors election have been announced, the Post Office lease was renewed, and the City is working with Texoma Council of Governments to administer the Low-Income Household Water Assistance Program. Mayor Pro Tem Nixon announced that he is running for City Council and appreciates everyone's support and vote. Councilmember Stephens announced he is also running for City Council.
