

## RESOLUTION 05112021-A

A RESOLUTION BY THE CITY COUNCIL OF THE CITY OF LEONARD, TEXAS, CANVASSING THE RETURNS AND DECLARING THE RESULTS OF THE GENERAL ELECTION HELD ON MAY 1, 2021, FOR THE PURPOSE OF ELECTING THREE (3) AT LARGE COUNCIL MEMBERS, AND REAUTHORIZING A LOCAL SALES AND USE TAX IN THE CITY OF LEONARD AT THE RATE OF ¼% TO CONTINUE PROVIDING REVENUE FOR MAINTENANCE AND REPAIR OF MUNICIPAL STREETS. THE TAX EXPIRES ON THE FOURTH ANNIVERSARY OF THE DATE OF THIS ELECTION UNLESS THE IMPOSITION OF THE TAX IS REAUTHORIZED

WHEREAS, on May 1, 2021, a general election was held in the City of Leonard, Texas, for the purpose of electing the following officials for the City: Three (3) At Large Council Members and Reauthorizing a local sales and use tax for maintenance and repair of municipal streets.

WHEREAS, the said election was duly and legally held in conformity with the election laws of the State of Texas, and the results of said election have been verified and returned by the proper judges and clerks; and

WHEREAS, the City Council of the City of Leonard, Texas, officially canvassed the returns on May 11, 2021, and hereby declare the result of such general election;

NOW THEREFORE, BE IT RESOLVED AND ORDERED BY THE CITY COUNCIL OF THE CITY OF LEONARD, TEXAS:

**Section 1**. The facts set forth in the preamble of this Resolution are hereby found to be true and correct and are incorporated herein and made a part hereof for all purposes.

**Section 2**. The official canvass of the returns of the general election held on May 1, 2021, reflects that the following named persons received the number of votes appearing opposite their names in the respective positions to be filled:
