City Manager Contract

AN ORDIANCE OF THE CITY OF LEONARD, TEXAS, CONFIRMING AND APPROVING AN EMPLOYMENT CONTGRACTG FOR THE EMPLOYMENT OF A CITY MANAGER; SETTING THE TERM OF OFFICE FOR THE CITY MANAGER; SETTING CONDITIONS AND AGREEMENTS RELATED TO THE EMPLOYMENT OF THE CITY MANAGER; PROVIDING FOR SERVERABILITY; AND PROVIDING AN EFFECTIVE DATE.

- **WHEREAS**, the City desires to employ Terry McCalpin as its City Manager upon the terms and conditions set forth herein; and
- **WHEREAS**, Terry McCalpin desires to work for the City as its City Manager upon the terms and conditions set forth in the City Manager Employment Contract.
- **WHEREAS**, the meeting at which this Ordinance is considered is open to the public as required by law, and the public notice of the time, place and purpose of said meeting was given as required by Chapter 551, Texas Government Code;

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF LEONARD, TEXAS:

- **Section I.** Findings The City Council of the City of Leonard finds the above and forgoing recitals are true and accurate and are hereby incorporated for all purposes as official findings of the City Council of the City of Leonard.
- **Section II. Terms and Conditions** The terms and conditions of the City Manager Employment Contract, attached as Exhibit A, are hereby approved, authorized and accepted. The Mayor is hereby authorized and directed to execute this Ordinance and execute and deliver an executed copy of the City Manager Employment Contract to Terry McCalpin for consideration and execution.
- **Section III. Authorizing Action** The City Council of the City of Leonard shall take appropriate action to effectuate the terms of this Ordinance and the City Manager Employment Contract approved hereby.
- **Section IV. Repealing Prior Actions** All prior ordnances or actions by the City of Leonard in conflict with the City Manager Employment Contract are hereby rescinded, voided, and repealed to the extent of that conflict.
- **Section V.** Saving Clause If any section, subsection, sentence, clause or phrase of this Ordinance is for any reason held to be unconstitutional or unlawful, such holding shall not affect the validity of the remaining provisions of this Ordinance.
