WHEREAS, City of Leonard "City" is a General Type A municipality in Fannin County, Texas, and


WHEREAS, the City has previously sought bids for the replacement of a 12-inch water line in connection with the Well 2 project, and

NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Leonard, Texas, as follows:


1. The City Council awards the bid to Lynn Vessels Construction for the contract price of \$ 276,099.66.
