May 14, 2024

1. Call Meeting to Order, Verification of Quorum
Mayor Pye called the meeting to order at 6:30 PM after confirming a quorum was present.

 Chad Leutwyler led the invocation, and the group recited the pledges of allegiance to the US and Texas flags.
- 3. Open Forum Mayor Pye called for speakers, and Chad Leutwyler thanked the council, the city, Police and Fire Departments for the Area-Wide Revival event held at the City Park April 21-25, 2024.

Mayor Pro Tem Noel Nixon moved to approve the minutes and after a second from Councilmember Philips, the motion passed 4-0.
