AN ORDINANCE OF THE CITY OF LEONARD, TEXAS, AMENDING APPENDIX A, "FEE SCHEDULE," OF THE CITY OF LEONARD CODE OF ORDINANCES BY REPEALING AND REPLACING ARTICLE A6.000, "UTILITY RATES AND CHARGES," TO REVISE RATES AND CHARGES FOR UTILITY SERVICES TO THE CITIZENS OF LEONARD; PROVIDING FOR INCORPORATION OF PREMISES; PROVIDING FOR AMENDMENTS TO THE CODE OF ORDINANCES; PROVIDING FOR SEVERABILITY; PROVIDING FOR SAVINGS AND REPEALER CLAUSE; FINDING AND DETERMINING THAT THE MEETING AT WHICH THIS ORDINANCE IS PASSED IS OPEN TO THE PUBLIC; AND PROVIDING AN EFFECTIVE DATE.

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF LEONARD, TEXAS, APPROVING THE REVISED CITY OF LEONARD POLICIES AND PROCEDURES FOR STATE AND FEDERAL GRANT-FUNDED PROJECTS, WHICH IS ATTACHED AS EXHIBIT A; PROVIDING FOR A REPEALING CLAUSE AND ESTABLISHING AN EFFECTIVE DATE.

## **RESOLUTION NO. 250819-05**

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF LEONARD, FANNIN COUNTY, TEXAS, APPROVING A PROFESSIONAL SERVICES AGREEMENT, ATTACHED HERETO AS EXHIBIT "A", ENTERED INTO WITH MARK LEDBETTER, A PRIVATE CONTRACTOR, FOR THE PURPOSE OF PERFORMING ALTERNATE OR TEMPORARY MUNICIPAL JUDGE SERVICES; PROVIDING FOR AN OPEN MEETING AND EFFECTIVE DATE.

- I. A motion was made by Councilmember Hanson to approve consent agenda items A-F, H&I, move agenda item G to September for comparison, seconded by Councilmember Martin. The motion passed unanimously.

  - I. The City Administrator presented the request for the permit. A motion was made by Councilmember Martin to approve application #2025-233 for LSA Football, seconded by Councilmember Wrenn. The motion passed unanimously.
- **8.** Presentation, discussion and possible action on Event Permit Application #2025-248 for the Leonard Chamber of Commerce to use the City Square and Library on Saturday, November 1<sup>st</sup>, 2025, from 10:30AM-5:30PM, for Halloween on the Square. (Debra Wilcox, Leonard Chamber of Commerce)
  - I. Debra Wilcox spoke about the request and the plan for the event. A motion was made by Councilmember Hanson to approve permit application #2025-248, seconded by Councilmember Martin. The motion passed unanimously.

  - a. Doug Morfeld spoke about a budget problem and proposed a solution. A motion was made by Mayor Pro Tem Stephens to move \$10,000 from lighting line item to Park Management line item, seconded by councilmember Martin. The motion passed unanimously.

#### **RESOLUTION NO. 250819-03**

A RESOLUTION OF THE CITY OF LEONARD, FANNIN COUNTY, TEXAS, APPROVING THE DESIGNATION OF THE CITY ADMINISTRATOR AS THE MAYORS DESIGNEE TO ANNUALLY PREPARE A BUDGET TO COVER ALL PROPOSED EXPENDITURES FOR THE SUCCEEDING YEAR FOR THE CITY OF LEONARD, TEXAS AND AUTHORIZING THE CITY ADMINISTRATOR TO REQUIRE ANY OFFICER, DEPARTMENT HEAD, OR OTHER UNIT OF THE CITY TO FURNISH INFORMATION NECESSARY TO PROPERLY PREPARE THE PROPOSED BUDGET; PROVIDING FOR THE INCORPORATION OF PREMISES; PROVIDING A SEVERABILITY CLAUSE; AND PROVIDING AN EFFECTIVE DATE.

- I. The City Administrator, George Evanko, spoke on the reasoning behind the resolution. A motion was made by Mayor Pro Tem Stephens to approve Resolution 250819-03, seconded by Councilmember Martin. The motion passed unanimously.

#### **ORDINANCE NO. 250819-04**

AN ORDINANCE OF THE CITY OF LEONARD, TEXAS AMENDING CHAPTER 10 "SUBDIVISION REGULATION", EXHIBIT 10A "SUBDIVISION ORDINANCE", SECTION 1 "GENERAL PROVISIONS", SUBSECTION 1.10 "INCORPORATION OF DESIGN MANUALS" OF THE CITY OF LEONARD, TEXAS, CODE OF ORDINANCES TO PROVIDE FOR AN APPROVED MATERIALS LIST; PROVIDING FOR INCORPORATION OF PREMISES; PROVIDING FOR AMENDMENT; PROVIDING FOR SEVERABILITY; PROVIDING A SAVINGS AND REPEALER CLAUSE; AND PROVIDING AN EFFECTIVE DATE.

I. The City Administrator, George Evanko, spoke on the reason behind the ordinance. Council member Hanson made a remark to make sure parts were stamped LF (lead free). A motion was made by Councilmember Hanson to approve the Ordinance 250819-04, seconded by Councilmember Grintz. The motion passed unanimously.

I. Councilmember Martin announced that the Fire Department has applied with the Texas Forest Service for a new fire truck. The application will not the approved until October for the Fire Department to decide on a new truck, it's a 10% match grant and the '96 truck will be retired.
