Public Hearing 2017-2018 Proposed Budget

The City Council for the City of Leonard, Texas will hold one public hearing on the 2017-2018 Fiscal Budget of the City of Leonard, Texas on Tuesday, September 12, 2017 at 5:30 p.m. in the Council Chambers at the City Hall, 111 W. Collin, Leonard, Texas. The meeting will be held for the purpose of receiving community input on the Budget, which will cover the Fiscal Year beginning October 1, 2017 and ending September 30, 2018.

"This budget will raise more revenue from property taxes than last year's budget by an amount of \$5,080.21, which is a .90% percent increase from last year's budget. The property tax revenue to be raised from new property added to the tax roll this year is \$287.52."

David Norman made the motion to table any action until Tuesday, September 19, 2017 with desire to better educate, communicate and to obtain input from citizens with a Public Hearing prior to the action item of action on Warrant Loan from First United Bank in amount of \$649,000.00. Dion Pontius seconded the motion. Motion carried, 4-1. Jane Blackerby opposed.
- 17. Council and City Administrator Comments Relating to Items of Public Interest: Announcements Regarding Local or Regional Civic and Charitable Events, Staff Recognition, Commendation of Citizens, Traffic Issues, Upcoming Meetings, Informational Update on City Projects, Awards, Acknowledgement of Meeting Attendees, Birthdays, Request of the City Administrator for items to be placed on Upcoming Agendas and Condolences.

Councilmember Norman stated that his suggestion of the Public Forum was to educate the public on why we needed a debt service, consider other options. To consider the needs of a community center or other options and layout a plan.

Councilmember Phillips stated, "we are not raising taxes to do this".

City Administrator Cox stated for information purposes, the amount of the bond is limited on the amount the city can repay on the bond. If the city has to get a million-dollar bond then the city would have to raise the water and sewer rates. To replace all the streets would take a 20-million-dollar bond and the city cannot float a bond like that. Each city is under constraints with their ability to repay the bond. You have to understand the information. This council has had workshop after workshop, you should have known something was going on. It's up to the Council, we are doing our best, we know we have a street problem.

Councilmember Bob Pannkuk stated if we could use the \$400,000.00 for streets, it might fix 4 or 5 streets.

Councilmember Phillips stated that the city is not broke, thanks to Jim Cox. City Administrator Cox stated that the collapse on Locust street was being repaired, the culvert had been set in and the backfill was in process. The cost of the culvert was \$2050.00.

He also updated the Council that Public Works had purchased two D-watering boxes for assistance in the drying beds at the Wastewater treatment plant at a cost of \$34,000.00 which was paid for out of this year's budget.
